Do you have staff that require upskilling? VERTO's Skills Checkpoint Program can support your staff with advice, assessment, and guidance on transitioning into a new role or career.

The program involves an initial career planning session to outline goals and specific needs and assist individuals to access suitable education and training options. Eligible Australians are able to access up to \$2,200 (GST inclusive) towards their training.
